1. Tender shall be submitted in the prescribed format for the car in a sealed cover superscribing “Tender cum auction for purchase of car bearing Regd. No. AS-09/A-4581” addressed to : The Chairman, Langpi Dehangi Rural Bank, Head Office, Diphu, Karbi Anglong, Diphu-782460.
2. Duly completed tender cum auction documents shall be submitted to our office at the address given above on or before 25.03.2015 by 2.00 PM. Tender will be opened on the same day at 3.00 PM onwards in the presence of intending bidders or their representatives who may be deputed to remain present at the time of tender opening. Only one Authorized Representative will be allowed to witness the tender opening and for auction upon submitting the authorization letter issued by the bidders. Bids received late will be **rejected**.
3. Earnest Money Deposit (EMD) of sum of Rs.1500/- is to be deposited along with application fee by way of DD/Banker’s Cheque payable at Diphu. Inter-se bidding will be permitted amongst the bidders only.
4. The bid amount is to be paid by way of Cash/DD favouring Langpi Dehangi Rural Bank, payable at Diphu. The person on being declared to be successful bidder shall deposit 25% of sale price, less EMD deposited **immediately**.
